Return Safe, Remain Safe Plan
Re-Entry Protocols

St. Paul Catholic School is asking each family to commit to the ***St. Paul Catholic School Return Safe, Remain Safe Re-Entry Protocols for the 2020-21 School Year***, to acknowledge that precautions that each of us takes or does not take affects our students, faculty and staff, and commit to the steps outlined below in order to safeguard the health of our school family.

St. Paul Catholic School has put in place reasonable preventive measures and standards of behavior to mitigate the spread of the COVID-19 virus at school. Even with implementation of safety protocols, the school cannot guarantee that your child nor anyone in our school community will not become infected with or exposed to COVID-19. By allowing your child to attend school, you understand and agree to the following:

1. If my child develops symptoms of COVID-19 while at school, I will be contacted by the school nurse or office staff, and I will make immediate preparations to have my child picked up and tested for COVID-19.
2. If my child leaves school because of COVID-19 symptoms, any sibling(s) will also be sent home.
3. COVID test results must be communicated to the school asap.
4. The school nurse or office staff has discretion to determine whether a student is ill or potentially contagious and whether it is in the best interest of the student, student body, faculty and staff to mandate that a child be picked up.
5. If my child contracts COVID-19, my child will need to be quarantined as directed by the Centers for Disease Control and Prevention (CDC), the Shelby County Health Department and the Diocese of Memphis, and my child will not be allowed to return to school until the mandatory 14 day quarantine has ended; home learning will be provided.
6. Any sibling(s) of a child removed from school because of COVID-19 symptoms must self-quarantine for 14 days; home learning will be provided.

7. If my child/family travels out of the immediate area to a state with a high positivity rate, my child will need to quarantine for 14 days from the date of return.

I will not bring my child to school if any of the following have occurred:

1. My child has developed a fever of 100° or greater in the past 24 hours.
2. My child has developed a new/unexpected cough or has shortness of breath.
3. My child has been in close proximity (such as a small group conversation or play for 10 minutes or longer) with someone exhibiting the above symptoms within the past 14 days.
4. My child has been living with someone who has been sick with COVID-19, has exhibited symptoms of COVID-19 or is currently under quarantine for exposure to COVID-19.

I acknowledge the receipt of the ***St. Paul Catholic School Safe Return, Remain Safe Re-Entry Protocols for the 2020-21 School Year*** and agree to adhere to and be governed by the protocols/guidelines for COVID-19.

I authorize the School to enforce other reasonable measures and directives as may be deemed necessary by school officials. I further understand that, in the event it becomes necessary that classes should be administered virtually (home learning), I understand that my tuition and fees continue to support the facility and academic programs of the school and for that reason, I agree to continue to pay my tuition and fees in support of the academic programs.
